Collection and Use of Personal Data

Purpose of Processing and Legal Basis

Teach Alliance will gather and process your personal data, which may include sensitive personal data, with the aim of delivering work-finding services. The legal grounds on which we base this processing are as follows:

- Consent
- Legal obligation
- Contractual obligation

Statutory/Contractual Requirement

Your personal data may be required by law, as well as for contractual obligations (e.g., at the request of our clients). Failure to provide this data may result in Teach Alliance being unable to engage with you further.

Data Retention

Teach Alliance will retain your personal data for as long as necessary. Different legal requirements dictate the retention periods for various types of data.

Under the Conduct of Employment Agencies and Employment Businesses Regulations 2003, we are obligated to retain work-seeker records for at least one year from their creation or the date of our last service provision to you.

Additionally, we must retain payroll records, holiday pay, sick pay, and pensions auto-enrolment records in compliance with HMRC regulations and associated legislation.

Upon expiry of any consent given for processing personal and sensitive data, Teach Alliance will seek renewed consent. Where consent is not provided, processing of your personal data will cease.

Your Rights

You are entitled to the following data protection rights:

- The right to be informed about the personal data Teach Alliance processes concerning you
- The right to access the personal data Teach Alliance processes concerning you
- The right to rectification of your personal data
- The right to erasure of your personal data in certain circumstances

- The right to restrict processing of your personal data
- The right to data portability in certain circumstances
- The right to object to the processing of your personal data based on public or legitimate interest
- The right not to be subjected to automated decision making and profiling
- The right to withdraw consent at any time
